Pursuant to Section 284 of the Municipal Act, 2001:

- a) The treasurer of a municipality shall in each year on or before March 31 provide to the council of the municipality or any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council;
- b) each member of council in respect of his or her services as an officer or employee of the municipality or other body described in clause (a); and
- c) each person, other than a member of council, appointed by the municipality to serve as a member of any body, including a local

board, in respect of his or her services as a member of the body.
