BY-LAW NUMBER 1518

A By-law to amend By-law Number 1455, as amended

The Council of the Municipality, in accordance with the provisions of the *Planning Act, RSO 1990*, as amended hereby enacts as follows:

1. By-law Number 1455, as amended is hereby further amended:
  - a. By changing Schedule A thereto, the zoning designation of the lands as shown outlined on Schedule A to this By-law in order to implement Policy 3.11.3 of the Municipality's Official Plan (Ministerial Approval, September 17<sup>th</sup> 2013).

2. That this By-law shall come into force and effect on the day that it is passed by Council, subject to the provisions of the *Planning Act*.
3. The Municipality's CAO/Clerk Treasurer is hereby authorized and directed to proceed with the giving notice of the passing of this by-law, in accordance with the *Planning Act*.
4. Therefore, it is recommended that a holding symbol be added to the MM Zone (MM(H)) on parcels 56042-0131, 56042-0012, 56042-0133 and 56042-0180 until the Township is satisfied that the following conditions are met:
  - a. The setback from the western boundary of the waste dump site to the East Mine Rock Stockpile footprint is addressed either through adjusting the mine footprint or through an Official Plan Amendment; and
  - b. The setback from Teeple Road to the East Mine Rock Stockpile is addressed either through adjusting the mine footprint or through a minor variance; and
  - c. The location of the ditch around the East Mine Rock Stockpile that currently appears to be on Teeple Road is identified and addressed to the Municipality's satisfaction.
5. That prior to development a Site Plan Agreement satisfactory to the Municipality shall be entered into between the Applicant and the Municipality and registered on title to all lands.

The purpose of By-law Number 1518 is to amend By-law Number 1455 as amended pursuant to an application by MMM Group Limited on behalf of New Gold Inc.

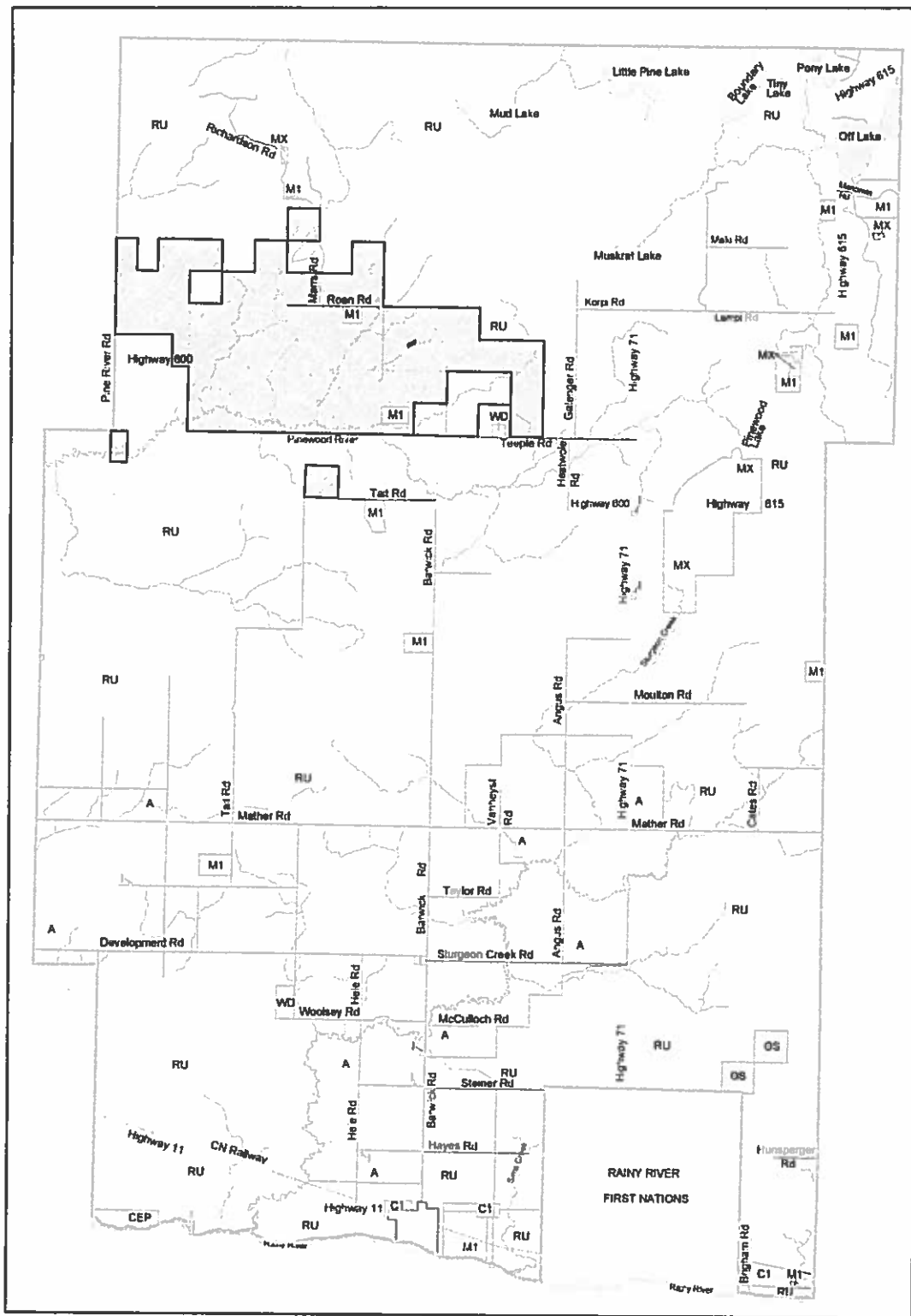
**Effect of the By-law**

The effect of By-law Number 1518 is to implement Policy 3.11.3 of the Municipality's Official Plan, which states that "following the completion of an Environmental Assessment, the Zoning By-law shall be amended to show the boundaries of the mine".

**Location of lands affected**

The lands affected by By-law 1518 comprise the lands listed in the Zoning Change Table and shown on Schedule A of this By-law.
