#### **DELEGATIONS:**

Sarah and Frances attend the meeting to seek support from Council for a licenced childcare facility in Emo.

There are three (3) licenced childcare facilities supported by DSSAB in the Rainy River District. These facilities are at maximum capacity and have a waiting list.

The committee will make application to the Ministry for a licence by the end of February. The facility will be located at the Knox United Church and will employ six (6) educators and one (1) cook. The number of children is determined by square footage. It is planned to accommodate ten (10) children aged 18-30 months, sixteen to twentyfour (16-24) preschool children age 30 months to 4 yrs and the balance school age children during school vacations and before/after school.

With the non-profit licence, families can apply for a subsidy with DSSAB for childcare costs. The subsidy is based on income.

The childcare facility would be operated by a Board that would include a municipal representative from the Township of Chapple.

Council was in agreement to provide a Letter of Support that will be sent to the attention of Tanis Fretter/Integrated Service Manager (Child Care) at DSSAB.

1:30 p.m. Joshua Colling/Fire Chief

Joshua Colling attended the meeting to provide Council with an update on the expectations for fire service and legal considerations for the Chapple Volunteer Fire Department.

Joshua reported that he believes the current 8 hours per week is not sufficient to complete all the duties for the Chapple Fire Dept. It is Joshua's recommendation that his position of Fire Chief for Chapple should be for 14 hours per week to ensure completion of fire prevention and public education.

Joshua continues to work on an "Automatic Aid Agreement".
