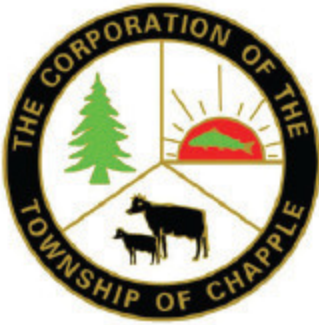

NOTICE OF COMPLETE APPLICATION AND STATUTORY PUBLIC MEETING AND COUNCIL MEETING FOR PROPOSED MINOR VARIANCES

TAKE NOTICE that the Council of the Municipality will hold a statutory public meeting of the Planning Advisory Committee followed by a Council Meeting on **Tuesday, June 16th, 2015, at 9:00 a.m.** in the Council Chambers at 54 Barwick Road, Barwick, ON, POW 1A0 regarding two proposed minor variances to the Zoning By-law under Section 45 of the *Planning Act*, R.S.O 1990, c. P. 13, as amended.

APPLICANT: New Gold Inc.

LOCATIONS: The intersection of Roen Road and Marr Road, and the intersection of Teeple Road and Highway 600.

THE PURPOSE AND EFFECT of the proposed minor variances is to request relief from Section 16.2 c) v. to:

- a) Reduce the minimum setback requirement from 30 metres to 9 metres along Roen Road (Richardson Con 2 E½ of N½ Lot 7 and Richardson Con 2 N½ Lot 6) for the proposed West Creek Diversion channel for the New Gold Mine (Figure A) ; and
- b) Reduce the minimum setback requirement from 30 metres to 8 metres along Teeple Road (Richardson Con 1 PT Lot 3 and Richardson Con 1 S½ Lot 2) for the proposed dams and berms of the East Mine Rock Stockpile (Figure B).

The effect of the minor variances is to permit mine-related development within the 30-metre minimum setback required for building, equipment, machinery, or stockpiling from the road allowance. The technical engineering design and topography for the dam, berm, and creek diversion cannot accommodate the required setback and so minor variances are required.

PUBLIC MEETING You are entitled to attend this meeting in person to express your views about this application or you may be represented by counsel for that purpose. If you are aware of any person interested in or affected by this application who has not received a copy of this notice, you are requested to inform that person of this meeting. If you wish to make written comments on this application, they may be forwarded to the committee at the address shown below.

FAILURE TO ATTEND If you do not attend the meeting, it may proceed in your absence and, except as otherwise provided in the *Planning Act*, you will not be entitled to any further notice in the proceedings.

NOTICE OF DECISION If you wish to be notified of the decision of the Committee in respect of this application, you must submit a written request to the Committee. This will also entitle you to be advised of a possible Ontario Municipal Board hearing in the event the decision on this application is appealed.

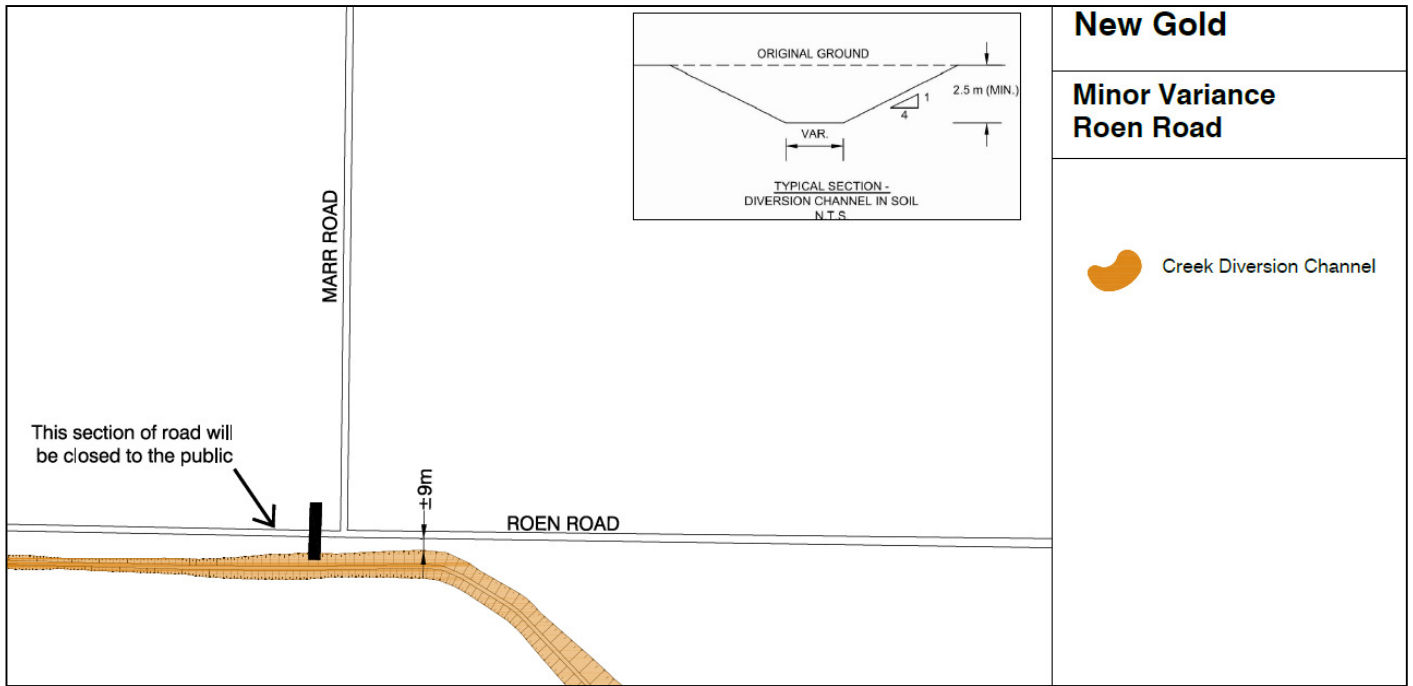

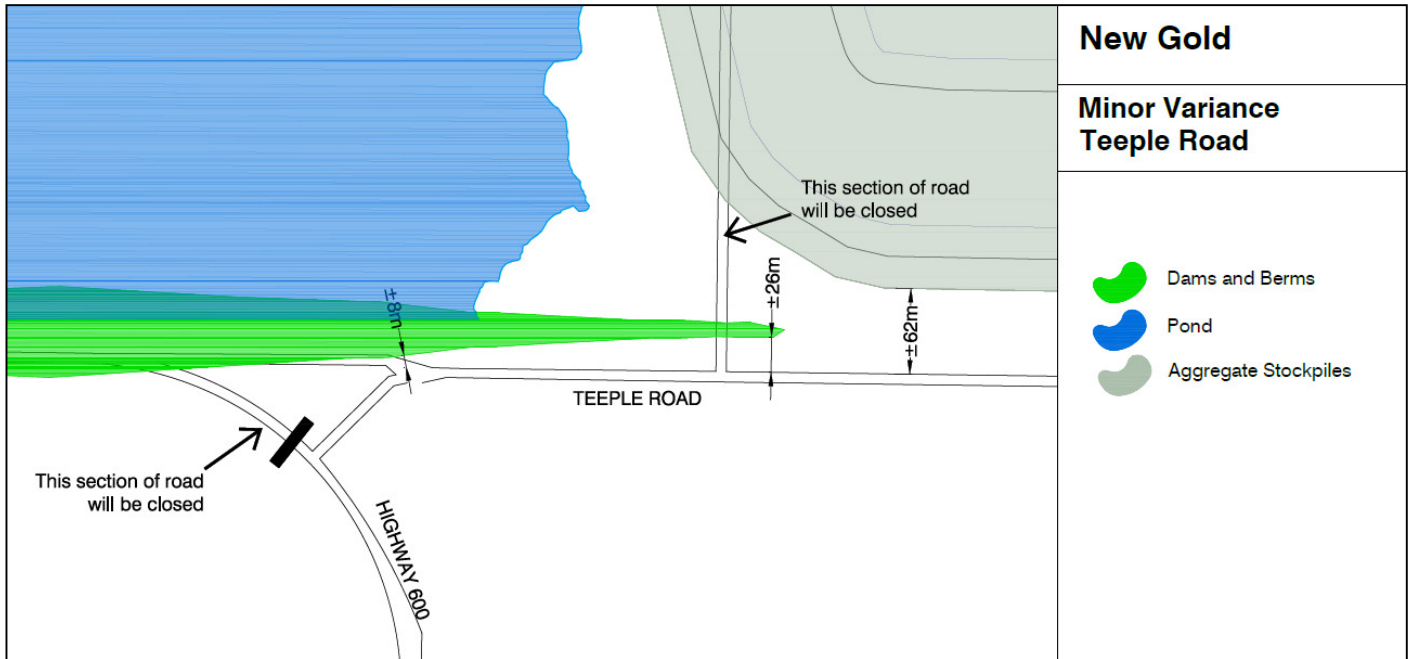
