The nomination shall be in the prescribed form; be accompanied by a declaration of qualification in the prescribed form; signed by the person being nominated (facsimile signatures are not acceptable); be accompanied by an endorsement of at least 25 persons unless the number of eligible electors in the subject municipality is less than the prescribed number (proposed to be 4000 electors) and be accompanied by the nomination filing fee of \$200 for the office of Mayor or Reeve or \$100 for all other offices listed herein. The filing fee may be paid in cash, by certified cheque or money order made payable to the municipality or, only if specified by the municipal clerk in your municipality, by electronic method of payment.
