



**THE CORPORATION OF THE TOWNSHIP OF CHAPPLE
BYLAW NO 1813**

BEING a by-law of The Corporation of the Township of Chapple hereby authorizing the Reeve and CAO/Clerk-Treasurer to enter into an agreement between the Corporation of the Township of Chapple and the Rainy River District Regional Abattoir.

WHEREAS the Rainy River District Regional Abattoir wishes to enter into an agreement with the Township of Chapple to dispose of non-hazardous, compostable material known as “offal” at Chapple’s Shenston Landfill, located on the S1/2 of SHENSTON, Section 22, PCL 5485,

AND WHEREAS the Municipal Council of The Corporation of the Township of Chapple agrees to this proposal,

NOW THEREFORE be it resolved that the Municipal Council of the Corporation of the Township of Chapple **HEREBY ENACTS AS FOLLOWS:**

1. That the Reeve and CAO/Clerk-Treasurer are hereby authorized to execute the Agreement on behalf of the Township;
2. That this By-law shall come into full force and effect on the date that it receives final reading

SCHEDULE 'A'

AGREEMENT dated this 14th day of March 2023

BETWEEN: THE CORPORATION OF THE TOWNSHIP OF CHAPPLE

AND: RAINY RIVER DISTRICT REGIONAL ABATTOIR

WHEREAS The Rainy River District Regional Abattoir wishes to enter into an agreement with the Township of Chapple to dispose of "offal," a non-hazardous, compostable material at Chapple's Shenston Landfill, located on the S1/2 of SHENSTON, Section 22, PCL 5485 Province of Ontario;

AND WHEREAS The Township of Chapple agrees to the proposal;

NOW THEREFORE, the Corporation of the Township of Chapple **HEREBY ENACTS AS FOLLOWS:**

1. That a secure area be established on the above-mentioned property to ensure safe disposal of compostable waste materials from the Rainy River District Regional Abattoir.
2. That proof of liability insurance, WSIB coverage, and all required permits, licenses, or other such applicable documents as required by the Ministry of the Environment, or any other agency be the sole responsibility of the Rainy River District Regional Abattoir to attain and produce upon request of the Township of Chapple.
3. That the Township of Chapple shall not be liable for any damages or loss sustained by this operation.
4. That, upon acceptance of this agreement, a tipping fee of \$50.00 per truckload be paid monthly on or before the 30/31 of each month thereafter. The tipping fee will be adjusted at the beginning of each calendar year based on October's COL, as determined by the bank of Canada.
5. That this agreement may be terminated by either party by giving ninety (90) days' notice in writing to the other party of its intention to terminate this agreement.
6. That this by-law shall come into full force and take effect on the date that it receives its final reading.
