For the Provision of Sewage and Water Services

1. I the undersigned (hereinafter called the Customer) do hereby request The Corporation of the Township of Chapple (hereinafter called the Municipality) to allow making necessary connections and provide sewage and/or water services at the premises listed and I undertake and agree to be bound by the rules and regulations and general conditions as stated herein and in Bylaw 968, Bylaw 1818, and as may be established from time to time by the Municipality.
2. This agreement shall not be binding upon the Municipality until accepted by it through its proper officers and shall not be modified or affected by any promise, agreement or representation, by any agent or employee of the Municipality, unless incorporated in writing into this agreement before such acceptance.
3. The Customer vacating the above listed premises without notifying the Municipality is liable for all subsequent accounts until a new Customer is registered the vacated premises. It is the Customer's responsibility and in their best interest to advise the Municipality in writing when they vacate the premises where they were registered for sewage/water services.
4. The Customer agrees that on request of the Municipality at its discretion, they will make a deposit to be held by the Municipality without interest as a guarantee that the Customer will fulfill the terms of this agreement.
5. The Customer will provide all plumbing on the premises and all sewer/water lines, connecting premises with the point of connection with the Minister of Environment's sanitary sewer and for water connections the water shut-off valve situated on the property line and maintain the same in efficient condition with proper devices.
6. The rates charged for sewage and water services are subject to change at any time on receipt of notice from the Municipality.
7. This agreement shall continue in force from year to year until terminated by a notice in writing, given by either party hereto at least one month before the end of the term or any year term thereafter.
8. The Customer agrees not to make any changes in or additions to their plumbing or connecting sewer/water lines after the same has been installed by the Customer and inspected by the Municipality except with the written consent of the Municipality.
9. It is agreed that the signatures of the parties hereto shall be binding upon their successors or assigns, and that the vacating of the premises herein names shall not release the Customer from this agreement except the option and by written consent of the Municipality.
