Following Council Resolution RES-133-2025, dated September 10, 2025, this vacancy will be filled by *Appointment by Call for Applications*. The successful candidates' term will extend from the date of Council appointment until November 2026.

### Eligibility Requirements:

Applicants must meet the following criteria, as set out in the Municipal Elections Act, 1996, Section 17. Subsection (2) Qualifications:

- (a) Resides in the local municipality or is the owner or tenant of land there, or the spouse of such owner or tenant;
- (b) Is a Canadian citizen;
- (c) Is at least 18 years old and;
- (d) Is not prohibited from voting under the Municipal Elections Act, 1996 Section 17 subsection (3) or otherwise by law.

### Application Process

Interested, qualified individuals may apply by submitting a Council Vacancy Application Form and Declaration of Qualification Form **in person, along with valid identification and Personal Statement** to the Clerk or designate. Clerk of the Township of Chapple will reject my nomination for the above-mentioned office if I fail to provide proof of resignation by this deadline.

- I am not a member of the Executive Council of Ontario or a federal Minister of the Crown.
  - I am not a Crown employee within the meaning of the *Public Service Act*, or if I am a Crown employee, I have followed and will continue to follow all the relevant provisions of Part III of such *Act*.
5. I am not prohibited from voting at the municipal election under subsection 17(3) of the *Municipal Elections Act, 1996*.

- I am not a person who is serving a sentence of imprisonment in a penal or correctional institution.
