## Take Notice that vacancies exist on the Township of Chapple's Council for one (1) Councillor position.

Following Council Resolution RES-133-2025, dated September 10, 2025, this vacancy will be filled by *Appointment by Call for Applications*. The successful candidates' term will extend from the date of Council appointment until November 2026.

#### **Eligibility Requirements:**

Applicants must meet the following criteria, as set out in the Municipal Elections Act, 1996, Section 17. Subsection (2) Qualifications:

- (a) Resides in the local municipality or is the owner of tenant of land there, or the spouse of such owner or tenant;
- (b) Is a Canadian citizen;
- (c) Is at least 18 years old and;
- (d) Is not prohibited from voting under the Municipal Elections Act, 1996 Section 17 subsection (3) or otherwise by law.

#### **Application Process**

Interested, qualified individuals may apply by submitting a Council Vacancy Application Form and Declaration of Qualification Form **in person**, **along with valid identification and Personal Statement** to the Clerk or designate. Applications and Declaration Forms are available at the Municipal Office or online at <a href="https://www.chapple.on.ca">www.chapple.on.ca</a>.

    I will provide proof of my resignation in a form satisfactory to the Clerk of the
    Township of Chapple prior to 9:00 a.m. on August 12, 2025, I understand that

Clerk of the Township of Chapple will reject my nomination for the abovementioned office if I fail to provide proof of resignation by this deadline.

- I am not a member of the Executive Council of Ontario or a federal Minister of the Crown.
- I am not a Crown employee within the meaning of the *Public Service Act*, or if I am a Crown employee, I have followed and will continue to follow all the relevant provisions of Part III of such *Act*.
- 5. I am not prohibited from voting at the municipal election under subsection 17(3) of the *Municipal Elections Act*, 1996.
- 6. Without limiting the generality of paragraph 5,
  - I am not a person who is serving a sentence of imprisonment in a penal or correctional institution.
- 7. I am not prohibited because of conviction of a corrupt practice described in s. 90(3) of the *Municipal Elections Act, 1996* from voting in a municipal election.

I am not a person who was convicted of a corrupt practice under the *Municipal Elections Act*, 1996 or of an offence under the Criminal Code (Canada) in connection with an act or omission with respect to a municipal election during the last two regular elections prior to Monday, October 24, 2022.

I am not disqualified from being elected to or holding office by reason of any violations of the election campaign financial requirements or violations for not filing the financial statement pursuant to the *Municipal Elections Act, 1996*. AND I make this solemn declaration conscientiously believing it to be true and knowing that it is of the same force and effect as if made under oath and by virtue of the *Canada Evidence Act*.
